ARCHITECTURAL REVIEW COMMITTEE

The Owner's discussed options with the Board regarding replacement of the roof and painting. They indicated it would cost them between \$19,000 and \$28,000 for the roof to be replaced. They indicated that they were unable to find anyone to paint the tile. The owners discussed placing solar on the roof as well. The Board discussed the issue of the concrete roof tile not being the correct style or color.

Upon a motion duly made, seconded, and unanimously carried, the Board approved the planting of seven entry pots at the cost of \$655.94. (Burke/Ross)

Mr. Hebert reviewed his report with the Board He reviewed the ongoing repairs to the coping on the pool. The Board discussed replacing the doors to the clubhouse. It was agreed to obtain proposals.

The Board discussed painting the existing pool tables a bronze color.

Upon a motion duly made, seconded, and unanimously carried, the Board approved the painting of the pool area tables and tennis area tables at the cost of \$1325.00 and purchase 18 new chairs for the tennis area. (Hebert/Ross)

Mrs. Ross stated that happy hour is going great. The committee discussed the Cinco de Mayo party preparations. She asked the Board to look at a sound bar speaker for the Television. It was agreed to research other ways for music to be played.
