CALL TO ORDER

APPROVAL OF PREVIOUS MEETING MINUTES

The Board reviewed the July 17, 2018 regular meeting minutes.

SPECIAL HEARING

Over the last several months ARC repeatedly asked a Patio II homeowner to reinstall muntins in their garage door windows. On August 13 the Board sent a letter to the homeowner demanding they comply with the Board request to 1) reinstall the muntins no later than August 20 or 2) attend a Special Hearing at the EVCC on August 21, 2018. The homeowner did not comply with either request. Board President Garry Denlinger reviewed ARC rules in relation to garage door styles. Per published ARC rules, garage doors with windows must be Stockton Colonial style (which include muntins). The fine for noncompliance is \$100. In addition, fines for repeat violations are doubled after due process of a second hearing. The Board will notify the homeowner of the \$100 fine and a second Special Hearing scheduled for 3:30 p.m. on September 18, 2018.

David discussed the on-going drain issue for the women's and men's bathrooms with Zech Plumbing. They recommended replacing a section of the drain located under the concrete slab. David agreed to obtain bid(s) to replace the drain pipe.

David Hebert volunteered to host the September 7th Happy Hour and Shirl Troxel will host the September 21st Happy Hour.

Community Center Manager's Report

Myrna Estremera reported there were no Clubhouse rentals in July. She also stated that one new hire is currently being trained.
