Upon a motion duly made, seconded, and unanimously carried, the Board approved the replacement of 6 - 15 gallon Canary Island Pine trees on the berm at the cost of \$900 to be paid from Reserves. (Chenet/Denlinger)

Facilities/Maintenance

Mr. Hebert provided the Board with a written report for the Board to review.

He informed the Board on the results of bidding out the replacement of the north trellis. He discussed the variety of bids and their costs. It was agreed to get more work done.

He reviewed an issue with the mortar around the spa area. He explained that the brick is also cracked and may need to have more work completed than just replacing mortar. It was agreed to obtain bids and review them at the January meeting.

Recreation/Social

The Board reviewed the upcoming holiday party on December 7th. The cost of the event will be \$30 per resident and Café Merlot is providing the catering.

It was noted that the happy hours for the month of December are being cancelled.

Community Center Manager's Report

Myrna Estremera reviewed her report with the Board. She stated that there is one new hire.

It was noted that bonuses for the employees will be based on the budget.
