#### **BOARD MEMBER REPORTS**

#### President's Report:

Garry Denlinger discussed a current covid-19 issue and requested several staff members get tested for COVID-19 and quarantine per CDC guidelines. The Board discussed management of the covid-19 protocol and abbreviated hours of operation due to covid-19 related issues.

## Secretary/Correspondence

Shirl Troxel discussed the opt-out form; 102 homeowners have submitted their form to the EVCC. John Kersey built a database to store all pertinent data. A discussion followed to identify methods to encourage homeowners to submit their opt-out form to the EVCC.

## Treasurer/Budget and Finance

John Kersey reviewed the financials with the Board to include the delinquent accounts report. Reserves are funded at 99.8%.

## Vice President Report/Personnel

The Board reviewed the written report from Tom Dudgeon in his absence. All staff performance reviews were completed and annual pay increases were implemented. One employee resigned to attend college and another employee was hired to fill the vacancy.

## Landscaping

Pat Chenet reviewed her written report with the Board. She reported Green Tech planted the Pygmy Date Palms, donated by Elite Community Management, in the front triangles on either side of the EVCC front walkway. Seasonal flowers will be planted around the palms in the next few weeks.

#### Facilities/Maintenance

David Hebert reported the contractor attempted to install the motor for the roll-up door in the small kitchen but it turned out another part is required.

Our termite insurance from Lloyd is up for renewal this month. The cost is still \$431. David recommended renewal of the policy.

A quote was received from ADT for camera surveillance of the parking lot and the spa as well as a motion detector and door sensor for the office. As David understands it, the amount for the parking lot and spa video surveillance includes an installation charge of \$3,780 plus a \$30 monthly recurring cost. The office alarm/monitoring would include an installation cost of \$199 and monthly recurring cost of \$30.
