## **BOARD MEMBER REPORTS**

#### President's Report:

Garry Denlinger reviewed the street light issue with the Board. The City is working on the repairs. Additionally, Garry discussed the possibility of obtaining earthquake insurance for the EVCC. It was agreed to further review the coverage.

#### Secretary/Correspondence

Shirl Troxel discussed current privacy laws that allow, with written permission, HOA's to provide official communications with homeowners and tenants via email. Shirl and Chris Hodge will create an appropriate form for the EVCC and present to the Board at a future meeting.

#### Treasurer/Budget and Finance

John Kersey reviewed the delinquent homeowner accounts with the Board. He stated that there are two owners past due more than 60 days. John also reviewed a summary of the May 31, 2019 financials, the Reserves Analysis and noted \$18,777 will be transferred to the operating fund from reserves. He stated that currently the reserves are funded at 97.8%.

#### Vice President Report/Personnel

Tom Dudgeon reported that Jonathan Ross submitted his formal resignation as he is now working at a full time job elsewhere. Tom and Myrna Estremera will be interviewing several applicants for a part-time staff position for the EVCC. Also, annual performance reviews will be will be conducted for all staff members and Myrna.

#### Landscaping

The Board reviewed Pat Chenet's written report. A vacuum breaker near the pool is leaking and was replaced at a cost of \$477. Green Tech will begin to clear a path on top of the berm, particularly around trees and irrigation -- as part of their monthly contract. In addition, Green Tech installed three - 5 gallon plants in the bare area on Escala and they re-located 11 euphorbia plants from the monument area and planted them in the succulent garden - at no cost. Pat, Myrna and Green Tech are evaluating options to change and/or improve the front entrance near the parking lot.

#### Facilities/Maintenance

David Hebert provided a written report for the Board's review. Colossus has finished the wood repair/replacement on tennis court 3. It was agreed to obtain bids to repair/replace the wood on court 2.

#### Recreation/Social

Nemira Stauskas reviewed the happy hour schedule for July and the Board agreed to cancel the happy hour scheduled for July 5<sup>th</sup>. Tom Dudgeon agreed to host the July 19<sup>th</sup> happy hour.

#### Community Center Manager's Report

Myrna Estremera provided a report on the monthly activities for the EVCC. There was one clubhouse rental in June.
