The Board reviewed and discussed the Covid Committee report. It was decided that only one person at a time will be allowed in the library and a mask will be required at all times.

Upon a motion duly made, seconded, and unanimously carried, the Board approved the reopening of the library as permitted by the rules effective April 26th. (Kersey/Hebert)

All other policies re the community center were reviewed and no other changes were made. It was noted that the recreational center is now open Sundays.

Treasurer/Budget and Finance

Mr. Kersey reviewed the financials with the Board. He reviewed the account balances and reviewed the expense through March 31, 2021. He noted that the expenses are lower than normal. He reviewed the delinquent accounts with the Board and one account was discussed. He reviewed the budgeting process with the Board and asked the board members for their budget categories.

The Board discussed the reserve study and the monthly reserve accrual for the upcoming fiscal year.

Upon a motion duly made, seconded, and unanimously carried, the Board approved the 2021/2022 Reserve study with an annual funding to reserve in the amount of \$55,608.00. (Kersey/Hebert)

The Board discussed the process of the budget approval.

Mr. Dudgeon reviewed his report with the Board. He noted that one of the employees has submitted his resignation. He said that Mrs. Estremera is continuing to search for a new employee. The Board discussed the ways to search for future employees in the community.

Landscaping

Ms. Chenet discussed her written report with the Board.

Mr. Hebert reported that the contractor has still not completed the modification to the motor of the roll-up door as promised.
