APPROVAL OF PREVIOUS MEETING MINUTES

The Board reviewed the April 19, 2022 regular meeting minutes.

Upon a motion duly made, seconded, and unanimously carried, the Board approved the April 19, 2022, regular meeting minutes as written. (Armstrong/Dudgeon).

ARCHITECTURAL REVIEW COMMITTEE (ARC)

Mr. Denlinger reviewed the Architectural Report with the Board. The Community Center applications were tabled. ARC recommended the Board consider modifying the remaining north trellis by adding a triangle-design replicating the look of the south trellis. This would improve the aesthetics of the trellis and make the look consistent throughout the facility. Installing lights is tabled until samples are received.

<u>Treasurer/Budget and Finance</u> The Board reviewed the financials and delinquent reports prepared by Mr. Kersey.

Vice President Report/Personnel

Mr. Dudgeon noted that all employees are working out well and he is looking for an additional staff person for the summer months.

Landscaping

The Board reviewed the tree proposal to trim the 14 Sycamore Trees at the center property.

Upon a motion duly made, seconded, and unanimously carried, the Board approved Union Tree Service to trim 14 Sycamore trees at the cost of \$4,200.00 (Denlinger/Armstrong)

Facilities/Maintenance

Mr. Denlinger reviewed the Maintenance report as prepared by David Hebert. He noted that the spa leak has been repaired by Aquaspec at no cost.

Discussion of north trellis replacement has been tabled until a later date.

The Board discussed tennis courts 2 and 3 fencing and windscreen.

Upon a motion duly made, and seconded, and unanimously carried, the Board approved an increase in cost to the previous month's approval for fencing and windscreen replacement to \$39,000.00 for courts 2 and 3 with reduced fencing between courts. (Denlinger/Dudgeon)

The court 4 pickleball conversion is complete. The Board agreed to sell two used pickleball nets at a cost of \$25.00 and \$50.00. The Board also agreed to donate one net to another center.

At a large clubhouse event, it was noticed that there was some back up in the sewer line. The Board discussed hydro jetting of the sewer lines and agreed to the repair.

Recreation/Social

Mrs. Lloret noted that we only have 31 persons signed up for the May Fiesta and it has been canceled due to the lack of interest. It was agreed to investigate other ideas for a community gathering in the summer. Mrs. Lloret will host Happy Hour on June 3 and Mrs. Armstrong will host on June 17.

Community Center Manager's Report

The Board reviewed the Managers report as presented. Summer hours will begin after the Memorial Day weekend. Mrs. Estremera discussed limiting the hours for summer evenings.

Upon a motion duly made, and seconded, and unanimously carried, the Board approved continuing the closing of the center at 8:00p.m. (Denlinger/Dudgeon)
