Treasurer/Budget and Finance

The Treasurer reviewed the financials for the month. He stated that the expenses are under budget and the reserves are at 109 percent funded. He recommended the Board moving \$20,000.00 from reserves to operating to cover reserve costs previously paid from the operating budget.

He noted that he signed the Auditors contract to have the review and taxes for the Association completed.

**Upon a motion duly made, seconded, and unanimously carried, the Board approved moving \$20,000.00 from reserves to the operating account, offsetting reserve costs previously paid from the operating budget. (Kersey/Dudgeon)**

Vice President Report/Personnel

Mr. Dudgeon stated that he and Myrna provided reviews to the employees. In addition, Mr. Dudgeon will be meeting with Mr. Denlinger to conduct Myrna's annual review.

Landscaping

Kathy Burke provided the landscape report for the Board. She discussed rebates for turf reduction and increasing the size of plants per a recommendation from the Architectural Committee. It was agreed to get an additional quote using one gallon plants in the triangle area and five gallon plants in the raised bed, then review with the Board.

**Upon a motion duly made, seconded, and unanimously carried, the Board approved the removal of a dead tree at the cost of \$700.00 to be paid from reserves. (Burke/Kersey)**

Facilities/Maintenance

The Board reviewed the report that Mr. Hebert provided in his absence. It was noted that the lights in the office were changed to LED lights at the cost of \$244.00.

An emergency repair of the Community Center AC was completed on Monday, June 26, 2017 at a cost of \$731. The compressor wouldn't start and blew fuses. A hard start kit was installed as a temporary fix. We began the process of getting quotes for replacement of the AC and possible upgrade from 4 ton to 5 ton.

**Upon a motion duly made, seconded, and unanimously carried, the Board approved the repair of the Air Conditioner at the cost of \$731.00 to be paid from reserves. (Kersey/Storer)**

Recreation/Social

Mrs. Ross stated that summer is busy and everything is running smoothly.

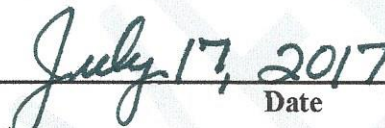
Upon a motion duly made, seconded, and unanimously carried, the meeting was adjourned at 4:20 p.m. (Kersey/Ross).
