**CALL TO ORDER**

**ARCHITECTURAL REVIEW COMMITTEE**

The board reviewed the Architectural Committee reports for February and March.

The Committee also asked the board to consider adding a new color for stucco. The board discussed the additional color and agreed to post a color swatch and information for the membership to review.

**BOARD MEMBER REPORTS**

**Presidents Report:**

Mr. Denlinger reminded board members of the Hats Off for Volunteers event on April 25, 2015. The board selected Ron Filson and would like to see a strong show of support from Eastview.

Mr. Denlinger asked board members to contact their vendors for next year's contracts. He also noted that three directors are up for re-election this June.

Secretary/Correspondence

Mrs. Denlinger reported that the website is complete.

Treasurer/Budget and Finance

Mr. Kersey reviewed the financial summary with the board. He reported that the Association is in a very strong cash position, noting that reserves are funded at 124.7% based on his current calculations. He reminded the board that the excess of reserve funding does not reflect the amounts due to operating funds from the reserve bank account.

Mr. Kersey informed the board that he will meet with David, Garry, and Paula to review the reserve study and budget.

Vice President Report/Personnel

Mr. Dudgeon did not have a report, and he will meet with Garry and Myrna over the next months.

Facilities/Maintenance

Mr. Hebert reported that the parking lot was resurfaced. He stated that the Community Center had some graffiti over the past month. He is now researching use of LED lights instead of high pressure sodium.

Mr. Hebert noted that people are jumping over the wall again and that he will research options to prevent this in the future.

Landscaping

Mrs. Taylor provided a written report and reviewed four work orders with board members. Two were approved as follows, and two were tabled for further review.

**Upon a motion duly made, seconded, and unanimously carried, the board agreed to approve work order #8647 for the amount of \$825.60 to be expensed out of reserves. (Taylor/T. Denlinger)**

**Upon a motion duly made, seconded, and unanimously carried, the board agreed to approve work order #8595 for the amount of \$2,525.54 to be expensed out of reserves. (Taylor/G. Denlinger)**

It was noted that work order #8595 for the Eastview entrance will be reviewed with the Patio I board. Should Patio I agree with the Community Center's recommended landscaping design, they will agree to install the same landscape for their side of the entrance area and will be responsible for their own costs.

Recreation/Social

Myrna reported for Ann that the Cinco de Mayo party will be held on May 1, 2015. The Social Committee opted to not use the Margarita machine for frozen margaritas due to cost and the machine's inability to serve a number of guests within a reasonable timeframe.

Community Center Manager's Report

Ms. De La Pena informed the board that she has been working on lights, a social party, and the website, and took a CAI Course for professional certification.
