# **ARCHITECTURAL REPORT**

The Board reviewed the most recent EVCC Architectural Committee report. Seven applications were reviewed and approved.

## **COMMITTEE REPORTS**

#### Landscape

Mr. Filson reported to the board that he met with the landscapers. He discussed the items that need to be reviewed by the landscapers. They were asked to trim the trees from the homes and over driveways.

Irrigation will be watering three days a week. Snail bait will be placed, and bait boxes are being inspected.

The Board reviewed the Landscape and Maintenance Request Forms submitted by owners. The owner items were addressed by the Landscape Committee.

#### Financial

The Board reviewed the financials for the month of May.

Cash increased \$42,525 from \$123,853 to \$166,378. The major reason was profit of \$19,435 and no payment to Green-Tech of \$22,500. The payment was made in early June. All other activity used cash of \$410.

The current month's expenses of \$27,829 were essentially on budget.

Year to date expenses of \$146,300 were favorable to budget by \$18,580. The main reason was lower water usage of \$14,589, lower landscape costs of \$2,956, and lower electricity costs of \$750. Since water bills from the city are way behind when the actual bills are received, they could vary from the estimated accrual of \$12,000.

According to the statements all homeowner accounts are current with only a small outstanding balance of \$70 which are late fee charges. It appears that charging late payers with late fees has motivated them to pay on time.

Upon a motion duly made, seconded, and unanimously carried, the Board approved waiving the late fees for owners as of May 31, 2023, in the amount of \$70.00.
