President's Message:

October is a historical month for all of Eastview. The 2007 fires had a major impact on our community. It is time again to think about cleaning up around our yards (fallen leaves/debris), remove dead bushes, trim vegetation away from our homes and our neighbor's homes, clean out rain gutters, and remove any combustible materials near our homes. Hopefully, by practicing fire prevention measures, we will never experience such an event again.

Updating our restated Bylaws and CC&R's: Your Board met with our attorney to examine the updated documents and amended the standard version to reflect Eastview Patio II Homes. We will be sending out a copy of these documents to all homeowners for their personal perusal. Next, a town-hall meeting will be called for owner/member's input. Once the amendments are accomplished, completed copies will go out with a ballot for approval. We will need at least 51% of the homeowners (77) to submit a ballot of approval to ratify. This procedure is necessary to update our 35-year-old documents to today's standards. Patio I has just completed the process.

Enclosed with this newsletter is a copy of the approved 2017 budget. There is NO INCREASE IN DUES, largely because of our two years of water savings. Our reserves are fully funded and our money market and CD's are leaving us in good financial shape.

We are using our excess funds to update our Bylaws/CC&R's, to add more water-saving sprinkler heads, to replace and refurbish our aging shrubbery, renovate front yard lawns, and to continue to anticipate some drought-tolerant landscape conversion. In addition, our hardscape is being repaired and painted (common walls), along with manhole covers, meter boxes and the weathered SDG&E box covers. Driveways are always a future concern as well. We are taking advantage of being fiscally sound to provide a fresh look for our community.

Landscape Report:



Fall landscaping has been focused on trimming bushes, raking leaves/pine needles, and cutting back front yard tree limbs that are close to or touching homes. Front yard trees will be formally laced in the spring of 2017. This is a repeated process every two years.

Some common area street and slope trees will be trimmed this winter. If a homeowner wants a certain tree to be trimmed during this time, please fill out a Landscape Request form obtained from the clubhouse or online. The Board will review each request and notify the homeowner. The homeowner will bear the cost. Pepper trees on Chretien and Colonnades, along with some slope pines, will be laced at the HOA's expense this year.

We are continuing to install water-saving MP rotor sprinkler heads throughout the community (Rosedown Place was just completed). Within the next few weeks, front yard sod replacement and winter rye will begin as the hot weather eases.
