## **APPROVE MINUTES OF LAST MEETING**

#### FINANCIAL REPORTS

The Board reviewed the financial statement for the period ending September 30, 2023. As of September 30, 2023, the operating account reflects a balance of \$56,923.21, the reserve account reflects a balance of \$186,134.40, accounts receivable reflects a balance of \$3,177.09 with total assets of \$246,234.70. The prepaid assessments total \$5,091.75 and the association is approximately \$6,200.00 over budget, mainly due to irrigation repairs. Vicki Owen will look into the repairs to confirm they belong to Eastview. A motion was made, seconded and unanimously carried to accept the financial statement for the period ending September 30, 2023 as presented for audit. (JM/VO)

The Board was given a copy of the final review from Steve DeMaine, CPA.
