FINANCIAL REPORTS

The Board reviewed the financial statement for the period ending August 31, 2022. As of August 31, 2022, the operating account reflects a balance of \$44,252.30, the reserve account reflects a balance of \$210,320.48, accounts receivable reflects a balance of \$13,078.84 with total assets of \$267,651.62. The prepaid assessments total \$4,091.00. The association is approximately \$12,000.00 over budget. PMC will research the last payment for water to determine if it was one water bill or two. A motion was made, seconded and unanimously carried to accept the financial statement for the period ending August 31, 2022 as presented for audit. (JS/MW)

The delinquency report was reviewed by the Board. PMC will generate letters to those who have balances on their accounts. A motion was made, seconded and unanimously carried to remove late fees from two (2) owner's accounts. (MW/JS)

COMMITTEE REPORTS

<u>Landscape</u>: The new controllers will be scheduled for installation closer to November when the weather is cooler as the water will have to be off for two (2) weeks.

<u>Architectural:</u> The Board reviewed the architectural report from the Eastview Community Center Clubhouse.
