APPROVE MINUTES OF LAST MEETING

A motion was made, seconded and unanimously carried to approve the October 19, 2022 regular meeting minutes as amended. (VO/AK)

FINANCIAL REPORTS

The Board reviewed the financial statement for the period ending October 31, 2022. As of October 31, 2022, the operating account reflects a balance of \$70,955.63, the reserve account reflects a balance of \$213,072.90, accounts receivable reflects a balance of \$4,319.59 with total assets of \$288,348.12. The prepaid assessments total \$9,201.75. A motion was made, seconded and unanimously carried to accept the financial statement for the period ending October 31, 2022 as presented for audit. (MW/JS)

The delinquency report was reviewed by the Board. A letter will be sent to those who have not paid the special assessment. If payment is not received by mid-December, the Board authorizes PMC to process pre-lien letters to the delinquent owners. A motion was made, seconded and unanimously carried to approve pre-lien letters to be processed in December if payments are not made. (VO/MW)

COMMITTEE REPORTS

<u>Landscape</u>: The Board reviewed the proposal from Atlas Tree Service to trim several trees in the community and do a chemical treatment on the pear trees to treat fire blight. A motion was made, seconded and unanimously carried to approve proposal #59828 in the amount of \$2,835.00. (VO/MW)

The Board reviewed the proposal from Aguilar Plant Care to treat a worm that has affected the liquidamber trees. A motion was made, seconded and unanimously carried to approve the Aguilar Plant Care proposal #15502 in the amount of \$415.00. (VO/JS) The treatment will be done in the appropriate the approximate the spring.

Architectural: The Board reviewed the ARC report.
