APPROVE MINUTES OF LAST MEETING

FINANCIAL REPORTS

De Board reviewed the financial statement for the period ending August 31, 2023. As of August 31, 2023, the operating account reflects a balance of \$77,865.23, the reserve account reflects a balance of \$184,521.45, accounts receivable reflects a balance of \$3,079.59 with total assets of \$265,466.27. The prepaid assessments total \$4,806.75 and the association is approximately \$14,900.00 under budget. A motion was made, seconded and unanimously carried to accept the financial statement for the period ending August 31, 2023 as presented for audit. (MW/JM)

The delinquency report was reviewed by the Board. One owner is more than 60 days past due and the Board requests a pre-lien letter to be sent. PMC will research a former owner's new location to refund an overpayment.

The Board reviewed the independent auditor's review. A motion was made, seconded and unanimously carried to approve the independent auditor's review. (MW/VO)

Landscape: PMC will follow up with Aguilar Tree Care to see if they have treated the trees.

Architectural: No report was given.

OLD BUSINESS

WEW BUSINESS

The Board reviewed the resident concern form regarding a neighbor's lack of landscape maintenance and debris in the side yard. PMC will send a courtesy notice to the resident's neighbor to maintain the landscape and remove any debris on the yard from neighboring homes.
