### APPROVE MINUTES OF LAST MEETING

## FINANCIAL REPORTS

The Board reviewed the financial statement for the period ending March 31, 2022. As of March 31, 2022, the operating account reflects a balance of \$140,148.79, the reserve account reflects a balance of \$84,263.33, accounts receivable reflects a balance of \$2,210.36 with total assets of \$226,622.48. The prepaid assessments total \$8,056.75. The association water is currently \$10,500.00 under budget and the association is under budget over by \$13,700.00. A motion was made, seconded and unanimously carried to accept the financial statement for the period ending March 31, 2022 as presented for audit. (MW/SC)

The delinquency report was reviewed by the Board. The Board agreed to give a delinquent owner until May 15, 2022 to bring their account current and if they don't, the Board will proceed with the association's collection policy. PMC will inform the owner that paying by credit card is an option through the Pacific Western Bank website.

The Board reviewed the proposals for the 2021-2022 audit review and tax preparation. A motion was made, seconded and unanimously carried to approve Steve DeMaine's proposal for \$900.00. (MW/SC)

### **COMMITTEE REPORTS**

<u>Landscape</u>: PMC obtained a reference for the proposed smart controllers indicating a water savings of approximately 35% for a community that installed the Jain Irrigation system. The Board has scheduled for the ballots for the special assessment for the smart controllers to be mailed on July 15, 2022 and the meeting to tally the ballots will be held on August 17, 2022.

<u>Architectural:</u> The Board reviewed the architectural report from the Eastview Community Center Clubhouse.
