FINANCIAL REPORTS

The Board reviewed the financial statements for the periods ending May 31 & June 30, 2023. As of June 30, 2023, the operating account reflects a balance of \$64,441.58, the reserve account reflects a balance of \$178,712.19, accounts receivable reflects a balance of \$2,474.59 with total assets of \$245,628.36. The prepaid assessments total \$5,649.25 and the association is approximately \$37,000.00 under budget. A motion was made, seconded and unanimously carried to accept the financial statements for the periods ending May 31 & June 30, 2023 as presented for audit. (AK/JS)

The delinquency report was reviewed by the Board. There are no new delinquencies.

COMMITTEE REPORTS

<u>Landscape</u>: The Board reviewed a proposal to replace a section of irrigation pipe along Escala. **A motion was made, seconded and unanimously carried to approve the irrigation pipe replacement. (VO/AK)**

The Board reviewed a proposal from Aguilar Tree Care to treat the liquidambars for caterpillars. A motion was made, seconded and unanimously carried to approve the treatment of the liquidambar trees. (JS/JM)

Vicki Owen reported she walked the property with Jose from Landscapes USA and identified several items for the crew to address.

Architectural: The Board reviewed an ARC application that was denied. The reason for the denial was that the owner wanted to take over a portion of common area. This is not permitted per the association's governing documents.
