Upon a motion duly made, seconded, and unanimously carried, the Board approved opening a CD in the amount of \$50,000 for a 16 month term.

He noted that he is asking for a quote from Clinkenbeard Insurance to provide a quote for the Board on the insurance needs.

Ms. Neidermeyer stated that she was notified of two new owners over the past month. She is giving welcome cards to the owners upon her visits.

## **Home Inspections**

I was reported that 30 letters were written and sent to owners for their deficiencies on their homes. It was noted that only 4 have been returned to date being completed.

#### Hardscape

Mr. Chenet stated that the committee will be reviewing the stucco wall repairs on Rosedown.

#### President's Report

Mr. Filson reported that the City has taken the two street lights and stated that they will be replacing them with the original style lights.

The Board reviewed the bee activity and it was agreed to keep going on the Bees removals when required.

The July newsletter is being put together and to provide all the material by July  $22^{nd}$  and will be mailed by July 25th.
