Dear Neighbors,

In our correspondence of June 25th, we advised you we would provide an update on the status on the EVCC facilities by July 9th. The board has determined we will implement a phased reopening commencing July 20th based on advice from the State of California, County of San Diego, City of San Diego and our attorney.

Hours of Operation

8:00 a.m. to 3:00 p.m. Monday, Wednesday and Friday (also, the 3rd Tuesday of the month).

12:00 (noon) to 8:00 p.m. Tuesday and Thursday

CLOSED – Saturday and Sunday

We will start with the pool reopening on July 20th for increments of 45 minutes. The remaining 15 minutes of each hour will be used for sanitizing purposes. Next, we will open court sports on July 27th for increments of 90 minutes. Indoor activities are not recommended at this time by State, County and City guidelines. The Stretch Class will not be allowed to meet since it takes place indoors.

Reservations are required for use of the Community Center facilities. Please call Myrna Estremera during the hours listed above at 858-487-7270 to make your reservation(s). You may call Myrna starting July 13th to make your reservation(s) for the week of July 20th. Each resident is allowed a maximum of (3) three reservations per week. Residents under the age of 18 must be accompanied by an adult age 18 or over.

Members will have their temperature taken with a touchless thermometer prior to entering the Community Center and will be asked to respond to a health survey regarding possible symptoms.

At this time no guests are allowed in any of our facilities.

Each resident must read and sign the attached Hold Harmless Agreement and bring it with you to the Community Center for your first reservation/entrance. A separate agreement is required for each minor child and it must be signed by an appropriate parent or guardian in the household.

All pertinent information as it relates to the EVCC/Covid-19 is attached to this communication and will also be posted on the EVCC website under the Covid-19 tab.
